To enter the Thai market, auto systems and spare parts must receive TISI certification. TISI, a regulatory institution for compulsory certification, falls under the jurisdiction of Thailand's Ministry of Industry. It is responsible not only for the formulation and management of

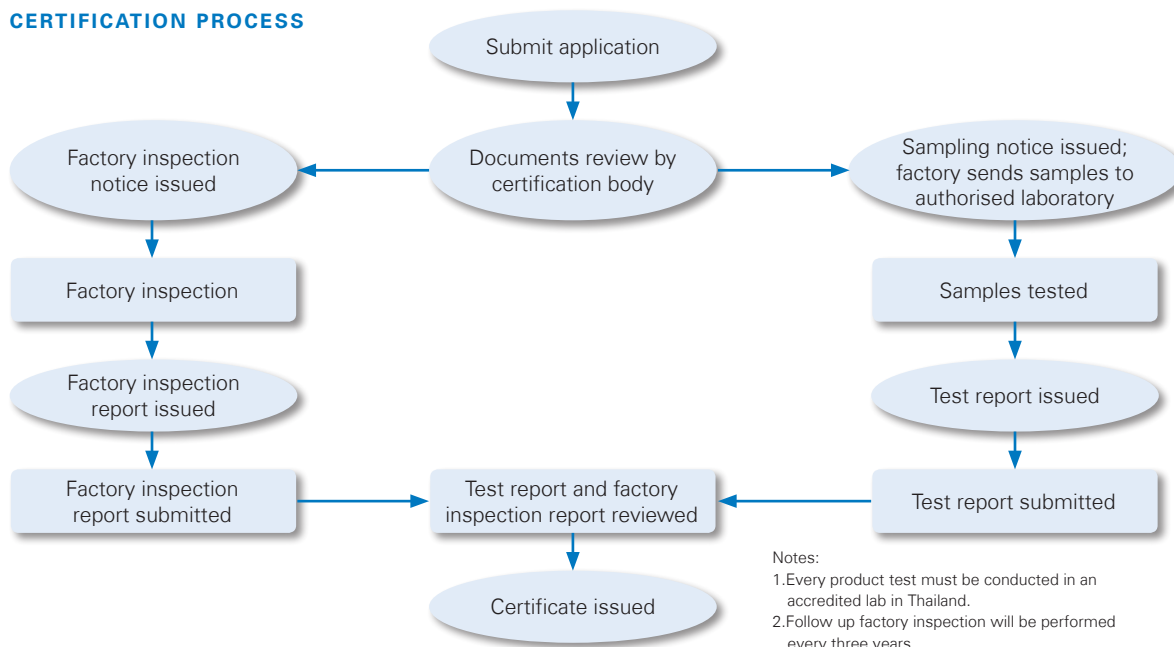
standards and the supervision of certification bodies, but also for laboratory accreditation, personnel training and qualification. TISI certificates has no expiry date, but certificate will become invalid in case the standard update or new standard implemented.
