Quality management

ISO 9001

The quality management system according to ISO 9001 is suitable for all industries and company sizes from start-ups to worldwide groups. With its process orientation, it takes into consideration the special requirements and perspectives of your company and is the basis for a continual process of improvement. This guarantees that quality orientation is anchored in the company for the long-term and is practised by every employee day to day.

Food

ISO 22000

The most important international food safety standard for companies of all sizes in the entire production chain – valid worldwide and therefore also ideal for export companies. The norm is based on the demands of a quality management system according to ISO 9001, extended to the HACCP principles.

HACCP

The Hazard Analysis and Critical Control Points System (HACCP) is the solid basis for hygiene management in companies. With HACCP, you regulate the enforcement and observance of the fundamental hygiene measures through to construction and technical requirements.

GMP+ (Good Manufacturing Practice)

The GMP standard includes specific hygiene requirements for production, trade and transport of fodder. The right start in systematic hygiene management.

IFS and IFS Logistics

German and French trading chains have defined quality requirements on their own brands in the International Food Standard (IFS). With a certification according to IFS, you verify that you comply with the standards for production and transport of own-brands products.

GobalGap

Food safety, health and safety at work, environmental protection and animal safety – large trade chains often expect a GlobalGAP certification from their agricultural suppliers. Global Good Agricultural Practices is an international quality standard for products of agriculture, horticulture or aquaculture.

IT + Information Security

ISO/IEC 27001

An Information Security Management System (ISMS) according to ISO 27001 creates high company security with suitable investment. The standard ISO 27001 interprets information security as an integral management task which goes far beyond the security of technical infrastructure. With the certified management system, you can systematically improve and control information security in your company.

ISO/IEC 20000

The international quality standard for IT Service Management offers IT service providers in particular a strong business basis. With a certification from TÜV Rheinland, you create the requirements for clear service contracts, better service, fewer risks and more checks of suppliers, such as costs. A certified ITSMS follows the basic concept of continual improvement. In this way, you can show that the services you offer are available and will continue to be available.

CSR and Sustainability

SA 8000

Internationally active companies need to show that they have responsible company policies: with certification from TÜV Rheinland according to SA 8000, you document that your company respects the protection and observance of social and employment law standards when providing services.

Sustainable Management

The standard for sustainable management developed by TÜV Rheinland has the goal of standardizing the understanding of sustainability in companies. BSCI

Promoting production conditions reconcilable with social standards is the stated goal of the Business Social Compliance Initiative (BSCI). FSC®

Products with the FSC® seal go through several stages from the forest to the end consumer and therefore several patterns of ownership. With the help of our certification, all companies along the product chain (chain of custody) guarantee to the consumer that wood products with the FSC® seal actually originate from a certified and responsibly run forestry company.

PEFC

The certification system for sustainable forest cultivation is based in terms of contents on international resolutions from various environmental conferences. Document and improve forest cultivation in terms of economic, ecological and social standards. The PEFC certificate signals sustainability along the entire product chain to the end consumer.

Mobility

ISO/TS 16949

The ISO/TS 16949 is the leading international automobile standard. Based on ISO 9001, the ISO/TS 16949 is perfectly customized to the requirements of the automotive industry. It specifies the requirements for development, production and – if applicable – also for assembly and maintenance of products. In so doing, ISO/TS 16949 focuses on customer satisfaction.

VDA 6.1, 6.2 and 6.4

With VDA volumes 6.1, 6.2 and 6.4, suppliers, traders, workshops and suppliers of production materials can optimize their work processes, as well as the use of raw materials and production materials. The certification is carried out as an addition to ISO 9001.

EN/AS/JISQ 9100 ff.

The EN/AS/JISQ 9100/9110/9120 certification comprises 3 major parts of a system: for development, production, assembly and maintenance (EN/AS/ JISQ 9100), for maintenance organizations (EN/AS/JISQ 9110) and for traders, distributors and stock keepers (EN/AS/ JISQ 9120). With your EN 9100, 9110 or 9120 certificate, you will be added to the OASIS database (Online Aerospace Supplier Information System) of the International Aerospace Quality Group (IAQG).

IRIS

The International Railway Industry Standard certification makes the quality of suppliers for customers from the rail vehicle industry transparent. Every certified company is added to the IRIS database from UNIFE, the Union des Industries Ferroviaires Européennes.

Energy and environment management

ISO 50001

The internationally recognized ISO 50001 specifies the requirements for an

energy management system and makes it possible for companies to continually improve their energy consumption.

ISO 14001

EMAS

Occupational health and safety

OHSAS 18001

The international standard OHSAS 18001 (Occupational Health and Safety Assessment Series) is suitable for all kinds of companies and fields. You systemize your health and safety activities and thereby improve the work processes connected with them. In practical terms, your occupational health and safety according to OHSAS 18001 can be integrated into the existing management system, e.g. according to ISO 9001 or ISO 14001.

SCC/SCP

Are you a technical service provider?

Then a certificate according to the standard SCC (Safety Certificate Contractors) could be of use to you to demonstrate the functioning of occupational health and safety vis-à-vis your customers. SCP certification (Safety Certificate Personnel) can improve your status as an employment agency with your customers.

Logistics and transport

ISO 28000

With ISO 28000 and certification, you avoid unnecessary risks for goods and plant along the entire supply chain. They tie in with the existing management system for protection against threats in norm ISO 28000 and sharpen the safety consciousness of your employees. In addition, you harmonize your safety-relevant processes and take a decisive step ahead in competitive terms.

TAPA

High-tech and other high value transport goods must often also be secured against theft. A TAPA certification (Technology Asset Protection Association) documents all security-relevant issues ranging from the order, through to the transport route and security consciousness of staff.

C-TPAT

For exports to the USA, safety aspects play a bigger and bigger role. The US customs authorities have therefore set up C-TPAT, the Customs Trade Partnership Against Terrorism, a voluntary partnership program. The stated aim of the C-TPAT is the complete security of the supply chain from foreign suppliers to American end consumers. With a C-TPAT validation from TÜV Rheinland, your shipments, to the USA are cleared faster and your basic credibility is verified.
